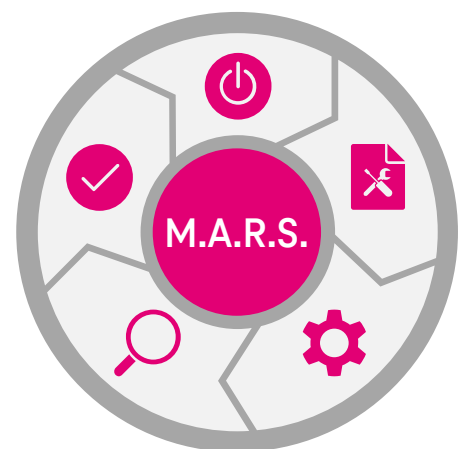

M.A.R.S. provides an end-to-end service to historize legacy data from post-productive system landscapes (SAP and non-SAP). 100% of Legacy data is extracted from the application and transferred to the platform. By mimicking the logic of the source system, the service is ensuring targeted access from anywhere and at any time. Historization reduces costs for operation as well as the necessary system and security updates. Your data are stored in an unchangeable, legally secure, and EU-GDPR-compliant manner. The historization is efficient and meets the requirements of the DACH region, such as data storage regulations (GoBD) in Germany, the Code of Obligations in Switzerland, and the Federal Tax Code in Austria.
